PURPOSE OF THE AGREEMENT

The Client wishes to hire Provider to provide services relating to the Client's wedding detailed in this Agreement. Provider has agreed to provide such services according to the terms of this Agreement.

TERMS

Booking Fee / Deposits

A non-refundable booking fee of 25% of the total package amount secures the time and services of the Videographer for the wedding and is non-refundable or transferable in the event of cancellation; it being the agreed loss suffered by the Videographer due to cancellation. The booking fee will be deducted from the cost of the clients chosen package when calculating the final payment due. Payment in full of the remaining balance will be due TBD. Weddings that are postponed to a later date will retain the fee, so long as the Videographer can re-schedule for the new date and time.

25% of the total due on TBD, in the amount of \$850

75% of the total due on TBD, in the amount of \$2,550

Services

5-7min Cinematic Highlights Film - Two Videographers for a total of \$3,400

The package of choice for most couples; two videographers allows us to ensure all angles & moments are captured. All day coverage by two videographers, with delivery of a 6-8min highlights film, and full-length ceremony, speeches, and dances. Plus, a 30-second teaser delivered within a week of your wedding!

- Drone Footage for a total of \$0

Drone footage is always included, as allowed by FAA regulations.

Wedding Arrangements

The details, itineraries, and arrangements of the wedding are to be agreed upon 30 days prior to the wedding in writing. The Client shall notify the Videographer of any changes to these details in writing.

Cancellation

The Client may cancel Videographer's services at any time by giving written notice to the Videographer, but in doing so shall forfeit any monies paid. Cancellation less than 4 weeks before the wedding will result in the payment in full becoming due. All cancellations must be in writing.

Display

The Client hereby allows the Videographer to display any photo, video, or audio covered by this contract to generally promote the business in advertising, websites, social media, or similar mediums.

Force Majeure or Act of God

The due performance of this contract is subject to alteration or cancellation by either party owing to any cause beyond their control. Although all equipment is checked regularly and reasonable steps are taken to ensure backup equipment is available, the Videographer will not be responsible for footage that is not produced due to technical failure.

Attendance

In the unlikely event of the assigned Videographer being unable to attend your wedding due to unforeseen circumstance, we reserve the right to appoint another videographer to attend your wedding on our behalf to undertake the wedding videography to his/her best ability and to a similar standard as the original videographer.

Limiation of Liability

In the unlikely event of total video/equipment failure or cancellation of this contract by either party or in any other circumstance the liability of one party to the other shall be limited to the total value of the contract. Neither party shall be liable for indirect or consequential loss.

Delivery of Final Products

The delivery of the final video(s) shall be by cloud storage unless specified otherwise by the Client. Said videos shall be delivered approx. 12 weeks from the date of the wedding. Once the final file(s) have been delivered, it is The Client's sole responsibility to store and preserve the file(s). 30 days after delivery, the Videographer assumes no responsibility for the storage of original or final file(s).

Filming on Location

When filming a wedding in an uncontrolled environment the Videographer is sometimes limited by venue restrictions, the layout of the venue, or the weather. It is understood by the Client that the videographer will work to the best of his ability in each location and judge the best shot for each set of circumstances.

Editing

By accepting these Terms and Conditions, the Client allows creative freedom in shot composition, direction, and editing for all final films & products. One revision of each final video file shall be offered to the Clients, for purpose of minor edits.
